  - (c) The boat owner agrees to accept full responsibility for the actions of such persons or organizations, and the owner agrees to indemnify and hold harmless forever Gonce Marine for any and all claims that may arise from work performed and/or the actions of those contractors.
2. All boat owners MUST MAINTAIN THEIR OWN INSURANCE COVERAGE to protect against liability, theft, pilferage, fire, wind storm, snow storm, vandalism or other casualty or loss.
3. It is expressly agreed by the boat owner that Gonce Marine is not in any way an insurer of the owner's property or family, invitees, employees or relatives. Gonce Marine shall not be liable for personal injury, loss of life, property damage to the described boat, motor, accessories or content thereof, due to fire, theft, vandalism, collision, freeze damage, wind storm, snow storm, rain, hurricane or other casualty, loss or negligence of Gonce Marine, its employees or agents.
4. In the event of litigation all attorney fees are the responsibility of the boat owner.
5. WE ASSUME NO RESPONSIBILITY for failure to repair any vessel at a certain time or date. However, Gonce Marine will exercise responsible diligence to accomplish same.
